Also, the revised National Policy on MSMEs has provided the desired framework for the sub-sectors coordinated development, which accounts for over 90% of total employment in Nigeria.

As we exit the Board of the Agency, it is our wish that the Agency will continue to receive the much-needed support from the Government so that it can deliver on its mandate. I also wish and pray that we will achieve more remarkable successes in our future endeavors.

To underscore and put in indelible mark, we have put together a compendium of the Agency's achievements during the tenure of this outgoing Governing Board. We hope that the Agency will keep the flag flying and let this become a tradition for subsequent Governing boards.






